- 2 Both the Tax Payer and the Spouse Info MUST be provided by <u>ANSWERING each field</u>.
- Please fill in answers to all blanks. If not applicable because you / spouse do not have State Photo ID, please write "N/A". Please do NOT return unfilled forms.
- 4 The US Tax Laws require us getting this information again and again every year. Sorry for the inconvenience.
- 5 Passport, Visa or NY <u>City</u> Photo ID or Employer Photo ID Info DO NOT constitute as a proof.
